Canon EOS 7D / WWT Promotion – Terms and Conditions

1. PARTICIPANTS

This promotion is only available on purchases made of the Canon EOS 7D (all configurations)

(the “**Promotional Products**”) within the United Kingdom (UK) & Republic of Ireland (ROI) between Monday 17th October 2011 and Wednesday 25th January 2012 inclusive.

- 1.1. All individual Participants must be aged 18 or over and must be resident in the UK & ROI (“**Participant**”).
- 1.2. This offer is not open to dealers of Canon photographic equipment.
- 1.3. The offer is only open to members of the Wildfowl and Wetlands Trust
- 1.4. All Participants are deemed to have agreed to be bound by these terms and conditions.

2. HOW TO PARTICIPATE

- 2.1. To enter the promotion, the Participant must purchase a Promotional Product within the UK or ROI during the Promotional Dates specified in clause 2.2 below AND submit a claim in accordance with clause 2.3 below.

- 2.10. Canon will endeavour to issue a voucher within 28 days of receipt of a valid claim.

- 2.11. The original receipt must be sent to the address specified in 2.3.2. with the claim form. Photocopies or illegible or damaged receipts will not be accepted.
- 2.13. Proof of posting is not proof of receipt.

3. THE PÁRAMO VOUCHER OFFER
