

## Terms & Conditions for the EOS Spring cashback promotion 1st April to 30<sup>th</sup> June 2010

### 1. PARTICIPANT

- 1.1. Participants must be resident in the European Union.
- 1.2. All participants are deemed to have agreed to be bound by these terms and conditions.
- 1.3. This promotion is only available on purchases of the Canon EOS 500D and EOS 50D (any configuration), in the UK or the Republic of Ireland from participating retailers.
- 1.4. Employees of Canon (UK) Ltd ("Canon"), its subsidiary companies, their families, agents and other parties directly involved with this promotion are not eligible to enter.

### 2. HOW TO PARTICIPATE

- 2.1. To enter the promotion, the participant must purchase the Canon EOS 500D or EOS 50D (any configuration), from a retailer within the UK or the Republic of Ireland during the promotional dates specified in Clause 2.2 below and must submit a valid claim in accordance with Clause 2.3 before the deadline detailed in Clause 2.4.
