

CANON POWERSHOT G11 ACCESSORIES CASH BACK PROMOTION – TERMS & CONDITIONS

1. PARTICIPANTS

- 1.1. This promotion is only available on purchase of a new Canon PowerShot G11 promotional box and subsequent purchase of one or several of the eligible products listed below under clause 3.1 within the UK or Republic of Ireland (“ROI”) between Thursday 1- October 2009 – Thursday 30- September 2010 inclusive.
- 1.2. All Participants must be aged 18 or over and must be resident in the European Union.
- 1.3. Those making claims on behalf of a company/business must be authorised by their Employer to do so.
- 1.4. All Participants are deemed to have agreed to be bound by these terms and conditions.
- 1.5. Purchases of non-promotional boxes are not valid under this promotion.

2. HOW TO PARTICIPATE

- 2.1. To enter the promotion, participants must purchase a new PowerShot G11 promotional box before 30- September 2010 inclusive and one or several of the products listed below under clause 3.1 (from any dealer within the UK or ROI) during the promotional period specified below in 2.2. The Canon PowerShot G11 promotional box must be purchased before **30- September 2010** and the subsequent purchase(s) must be made before **1- November 2010** to be eligible for this promotion. Purchases made after midnight on 1- November 2010 will not be eligible under this promotion.
